Thursday 8th March, Leeds

Northern Powerhouse, Strategic Planning and the Pan-Regional Agenda

The pan-regional agenda is at the forefront of government thinking on industrial strategy, economic development and infrastructure investment. This conference will look at the agenda in the North from a range of perspectives; examine lessons for planners from progress to date; and consider the implications for strategic and local planning.

Thursday 5th April, Leeds

Planning for a cohesive and diverse community

There are many challenges for planning in relation to diversity, housing, tolerance and community safety. This conference will explore the issues of diversity, inequality and community cohesion and reflect on ways to support all communities.

Thursday 17th May, York

Development Management Law

The aim of this well-established conference is to keep delegates up to date on legal aspects of all sides of development management. This year it is organised by Squire Patten Boggs. Barristers from No 5 Chambers will again speak. This is consistently one of our top conferences.

Thursday June 7th, Sheffield

Affordable Housing: emerging responses to the housing crisis

In the UK, the availability of suitable homes is not meeting demand. This conference will explore what planning and those involved with housing development can do to tackle the housing crisis. The issues will be considered in terms of increasing the delivery and diversity of affordable housing in the UK.

Thursday 21st June, Leeds

Design, conservation and the built environment

This conference will review how we value our heritage assets. We will consider how planners can conserve community assets for local communities and reflect on the role of external agencies to support and encourage conservation. We will consider the best approaches to safeguarding and providing a legacy for future generations.

Thursday 12th July, Sheffield

Planning for water management

Climate change, development pressures and the water framework directive have pushed water management up the planning agenda, stimulating new approaches, including SUDS and making space for water. This conference will focus on the latest best practice in planning and water management and its creative potential in place making.

Thursday 20th September, Leeds

Housing and economic development within the 'Northern Powerhouse'

This conference will explore how strategic planning decisions have been made in the combined authorities and whether this represents a return to regional spatial planning by the back door. Given the trends to cross boundary consultation on housing needs assessment and the operation of economic and labour market areas, we will consider what relevance this has for planners and maintaining community engagement and involvement.

Thursday 11 October, York

Development Management Practice

Different aspects of good practice in development management will be covered including appeals, the NPPF and enforcement. We will also look at management challenges at a time of great financial pressure. The conference will be very useful to planning practitioners in both the public and private sectors.

Annual Planning Law Update
